## Request For Group Visit

This form must be completed at least a month before the requested date whenever a group of visitors wish to make use of the club facilities. The event will be added to the club Event Calendar.

A group is defined as more than one visiting family or boat and may not necessarily be a regatta. Every visiting group must have a BLSC member host who will be appointed by the executive if necessary. The host BLSC member is responsible for initiating this form.

### Host responsibilities

- The host BLSC member must be on the club site for the whole time of the visit or delegate responsibility to a responsible visitor who is familiar with the requirements of group visits.
- The host must ensure that visitors are aware of and comply with club rules – see below.
- The host is responsible for collecting the contribution towards club expenses that was agreed at the time this form was submitted to BLSC VC Fleet.
- The host is responsible for ensuring that the Informed Consent form is signed by all adults taking part in the group visit, parents/guardians signing for their children.

### Club Rules For Visiting Groups

- Camping only in the field
- ‘Dry’ camping only
- Vehicles, trailers and campsites must not obstruct access to club boats or launching ramp.
- Only one open fire is allowed on the site – in the field fire pit.
- Picnic tables taken from the picnic area must be replaced before leaving.
- Use may be made of all clubhouse facilities while ensuring that the clubhouse and grounds are kept clean and tidy at all times. Dishes and utensils must be washed and put away after use.

- All garbage must be collected in the visitor's own containers and removed from the site. BLSC does not have garbage pickup.
- Any planned unusual use of the site must be OK'd with BLSC Exec (e.g. music, large scale games)
- Swimming is not allowed from the launching dock or the leeward side of the black mooring dock.
- Fishing is not allowed from the club docks or shoreline
- Pets are to be tied up or on a leash at all times. They must be kept quiet and are not allowed to swim in the lake except from the back beach. Pick up and remove any pet mess.
- Powerboats and PWCs are not allowed at BLSC except for the club boats and any brought by the visitors for safety purposes.
- Visitors must not operate club power boats, except in an emergency. Anyone who operates a power boat must have a Canadian Pleasure Craft Operator License. Gas used in the club boats must be replaced.
- Club race equipment may be borrowed from the garage and returned in good condition.
- Visitor regattas are not allowed at the same time as club racing and visitor boats must be removed from the beach and club docks one hour before club racing starts.
- All visitors intending to sail while visiting must sign and date a waiver form available in the clubhouse. The completed forms are to be left pinned to the notice board in the clubhouse.
- Any damage to club property or equipment must be reported to the executive. BLSC expects to be reimbursed for cost of repairing any damage.
